- 1. Name of the society shall be "COMMUNITY ORGANISATION FOR OPPRESSED AND DEPRESSED UPLIFTMENT" (COODU).
- 2. The Registered Office shall be at 89-A, Kattor Street, Papanaicken Palayam, Coimbatore - 641 037.
- 3. Objectives of the Society are :
- a) To raise General Awareness among urban, rural and hilly area poor to enable them to organise themselves for socio-economic educational and cultural development with self-reliance.
- b) To eradicate the social evils of the society such as child labour, street children, child marriage, child abuse, Juvenile delinguency, etc. through appropriate rehabilitation measures and assistance.
- c) To impart life education to the poor and needy with stress on improve methods and appropriate techniques in Agriculture, Health, Mother and Child care and other relevant topics.
- d) To provide opportunity for street and working children to develop themselves with necessary facilities of education, health, shelter and recreation to those who have missed schooling.
- e) To rehabilitate handicapped, destitute, deserted and street and working children, widow and aged people of the society.
- f) To participate or conduct any research activities related to community development education, childrens education, community health and socioeconomic development and any subject related to women and childrens development.

- To run hospital, health education centres or other Institution for reception and treatment of persons suffering from illness or mental defectiveness or for the reception and treatment of persons during convalascence or of person requiring medical solely intention or rehabilitation philanthrophic purpose and not for purpose of any gain or profit.
- To promote awareness on HIV/AIDS prevention and control among CSW's pimbs, brokkers etc., as well as h) general public of the society.
- To create IEC meterials and to promote counselling i) centre for prevention and control of /HIV/AIDS and drug addition.
- To promote environmental awareness to j) preserve and promote ecological balance sustainable agriculture among hilly and rural people for harmonious living with nature.
- k) To initiate suitable action by means publicity, training etc. for encouraging forestry schemes both independently and collobaration with other national and international agencies.
- To initiate, educate and promote consciousness among the rural and urban masses on ecology, environmental cleanliness and prevent pollution of all kinds.
- To create awareness among all section of people m) regarding the social evils like alchoholism, dowry system, caste system and oppressions etc. and enable them to wean away from the society.
- To render free Legal Aid for poor and impart legal n) education and training to promote their fundamental rights and enjoy privileges as citizen.
- To conduct orientation programme for social workers on basic law of our nation in order to equip them to and ri understanding law of our nation and desseminate knowledge about their obligation and rights as citizen of our country

- conferences, training programmes and any such activity in order to fulfil any of the objectives.
- q) To produce, publish and desseminiate information on women and childrens development in all appropriate media forms such as Magazines, News letters, Folkarts, Vedio, Audio programmes, Electronic Media and interpersonal communication aids.
- r) To set up one or more resource centres, documentation centres to fulfil the objectives of the society
- s) To utilize all necessary expertise, skills and service by hiring, appointing, consulting, collaborate with individuals/organisation who may be required for fulfilling any one of the societie's objectives.
- t) To co-operate and collaborate with any organisation, Government or individual on specific for unorganised labourers, women and childrens development related programmes/projects.

u) To take any step and organise any further activity that may become necessary in furtherence and fulfilment of any of the abovesaid objectives of the society.
